Tender Description

Invitation to submit tender for the Provision of emergency fodder grass (Sudanese grass) for 794 vulnerable droughts affected Agro-pastoral HHs in BaladulAmin,Bandiiradley, Baxdo gaabo, Budbud village, Buulaley,Carfuuda,Dagaari,Docol,Jilable Hayre, Laasacadalle villages in Galkacayo south district

Background

Peace and Development Action (PDA) is registered with the Government of the Federal Government of Somalia as Non-Governmental and Not-for-Profit Organization with a vision is to be a leading Somali-based Non-Governmental Organization that strengthening the capacity and expression of ordinary citizens to become resilient and participate freely in the sustainable development of Somalia. Key thematic areas of intervention include; Democracy & Good Governance, infrastructure development, food security, gender mainstreaming, peacebuilding & conflict resolution, food security, participatory budgeting and human rights advocacy.

PDA is headquartered in Mogadishu with regional offices in Cadaado, Hobyo, Jowhar, Galkacyo and Kismayo.

In partnership with Somalia Humanitarian Fund (SHF), PDA intend to do emergency distribution of fodder grass (Sudanese glass) through voucher in Galkayco South, Somalia to 794 HH in Baladul Amin (90HH), Laasacadalle (80HH), Carfuuda (65HH), Bandiiradley (70HH), Baxdo gaabo (85HH), Budbud (90HH) Buulaley (80HH),Dagaari (74HH),Jilable Hayre (80 HH) and Docol (80HH) villages. Each HH will received will received 4 bundle/Bales of 25 kg Sudanese grass for two rounds (see the details in annex 1).

The tendering will be conducted using PDA procurement procedures and bidding documents. All tenders are open to all qualified local suppliers in Galkacyo South district. Interested and eligible local vendors/suppliers with sound capacity, relevant experience in similar work experience, sound financial capacity and registered with Galkacyo Authorities are thus invited to collect tender document from PDA offices in Galkacyo or Mogadishu.

Requirements for Tender Documents

1. Tender envelop should be sealed with reference number embedded
2. Company Profile with detailed physical address
3. 3 months recent Bank statement

4. Valid Registration certificate from Galkacyo. Federal government registrations are an added advantage.
5. Quotation price.
6. Evidence of past relevant experience

All bids should be written in English.
