# **Tender Description**

Invitation to submit tender for the Provision of clean water supply through water trucking through water voucher to 1640 drought/AWD affected households in; Ceel Mudey and Buulo Mardaaf locations in Afgooye district, Somalia for 40 days

# Background

Peace and Development Action (PDA) is registered with the Government of the Federal Government of Somalia as Non-Governmental and Not-for-Profit Organization with a vision is to be a leading Somali-based Non-Governmental Organization that strengthening the capacity and expression of ordinary citizens to become resilient and participate freely in the sustainable development of Somalia. Key thematic areas of intervention include; Democracy & Good Governance, infrastructure development, food security, gender mainstreaming, peacebuilding & conflict resolution, food security, participatory budgeting and human rights advocacy.

In partnership with Somalia Humanitarian Fund (SHF), PDA intend to award a contract to clean water trucking through voucher in Ceel Mudey and Buulo Mardaaf locations in Afgooye district, Somalia to 1640 HH whereby each household will receive 45 liters of water per day for 40 days (see the details in annex 1).

The tendering will be conducted using PDA procurement procedures and bidding documents. All tenders are open to all qualified local suppliers in Afgooye district. Interested and eligible local vendors/suppliers with sound capacity, relevant experience in similar work experience, sound financial capacity and registered with South West Authorities are thus invited to collect tender document from PDA offices in Afgooye or Mogadishu.

### **Requirements for Tender Documents**

- 1. Tender envelop should be sealed with reference number embedded
- 2. Company Profile with detailed physical address
- 3. 3 months recent Bank statement
- 4. Valid Registration certificate from South West state. Federal government registration is an added advantage.
- 5. Quotation price.
- 6. Evidence of past relevant experience of water trucking

All bids should be written in English.

## Conditions;

- a) The selected supplier shall ensure that the water provided is safe for human consumption with accordance with the WHO drinking water quality
- b) The selected supplier shall ensure that water supplied is treated prior to delivery
- c) The selected supplier will be responsible for delivery of water to PDA designated locations
- d) The water trucks shall be equipped with a water pump and other necessary equipment's for filling the water tanks
- e) PDA team members will be assigned for each delivery locations to monitor the delivered water and water quality testing

## Tender Submission, duration and deadline

The tenders will be opened and evaluated by PDA procurement committees and thereafter notify the successful vendors to start the service immediately.
